Hello Dania,

I hope and you and your family are safe and healthy,

This is a reminder that the previous extension request for Xerox expires on June 10, 2020. Please seek further approval from your Board to grant another 6 month extension.

On the subject of extension requests, we would also like to remind that you were recently notified of the following downgrades: Occidental [requires extension approval by 9/25], Macy's [requires extension approval by 10/02], and Ford [requires extension approval by 10/04].

Given the present COVID-19 uncertainty, I'm guessing your Board meetings will entail unknown logistical considerations going forward, like when they are able to next meet. We would appreciate it greatly if you would also seek approval to grant an extension for each of the aforementioned below investment grade issuers, to be applicable for six months beyond the current expiration dates referenced above.
